Public Notice

Counselling for admission to MD/MS/PG Diploma and MDS Courses in all Government/ Government Aided/ Private Unaided Medical/ Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University Bahadurgarh, Jhajjar in the State of Haryana for the Academic Session 2019-20.

It is for the information of all the eligible candidates desirous of seeking admission to PG (MD/MS/PG Diploma/MDS) courses for the academic session 2019-20 and all other concerned that fresh registration for second round of counseling for admission to PG courses for the academic session 2019-20. The tentative schedule for 2nd round of counseling is as under –

- a) The candidates who have already registered themselves for the first round and wish to participate in the second round, shall not be required to register again. The candidates who have got their document verification done during the first round of counseling are not required to get documents verified again.
- b) The candidates who have been allotted seats in the first round of counseling shall have to give their willingness/option to upgrade themselves in the second round of counseling online otherwise they shall not be considered eligible for the second round of counseling.
- c) The Candidates who have joined on the allotted seat in the first round shall have a right to already allotted seat and this shall be changed only if he/she gets an updated and opted seat during second round. However, the candidates who wish to participate in the 2nd round of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in first round should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.
- d) The candidates who have been allotted seats in the first round but do not join the allotted seat will also have to give their willingness to participate and submit fresh choices for the second round
- e) All candidates {already registered (irrespective of their admission status) and freshly registered candidates} who wish to participate in the second round of counseling and want to opt for State Quota Seats in only Government/Government aided Medical/Dental Institutes shall be required to submit a demand draft of Rs.25,000/- (Rs.12,500/- for SC/BC of Haryana state) in favour of Controller of Finance, Pt.B.D.Sharma University of Health Sciences, Rohtak to the Admission Committee. The demand draft will have to be deposited to the Chairman Admission Committee between 19.04.2019 to 23.04.2019 either by the candidate himself or through authorized representative. If the candidates wishes to also opt for State Quota Seats/Management Quota Seats Private Medical/Dental Institutes including Private Universities then he/she shall have to submit a DD, of Rs.2.00 Lakh in favour of Controller of Finance Pt.B.D.Sharma University of Health Sciences, Rohtak to the Admission Committee.

The candidates who wish to participate in 2nd round must submit the requisite Demand Draft of Rs.25000/-(Rs.12,500/- for SC/BC of Haryana state) or Rs.2.00 Lacs as the case may be, failing which they will not be considered eligible to participate in the 2nd round of counseling. This amount shall be later on adjusted in the fee of the first year of PG Course. The Demand Draft of the candidates who are not allotted seats during the 2nd round shall be returned after the completion of the counseling process.

f) The candidates who are allotted seat in the 2nd round of counseling but do not join, their Demand Drafts of Rs.25000 (Rs.12,500/- for SC/BC of Haryana state) /Rs.2.00 Lakhs submitted to the Admission Committee shall stand forfeited, however they will be eligible to participate in the mop up round.

The candidates who join the seat allotted to them during the second round of counseling shall not be eligible to participate in the Mop up round.

Note:-

- The choices filled by the candidates for the first round of counseling shall be treated as null
 and void and the candidates will have to fill fresh choices to be eligible for participating in the
 second round of counseling.
- Seat matrix for the 2nd round of counseling will be displayed only when the vacant seats from the All India Quota are reverted to the State.
- If a candidate does not report for document verification or does not deposit the demand draft as explained above he/she will be considered ineligible.
- The above instructions should be read alongwith the Notification dated 19.03.2019 & any subsequent Notifications issued thereafter.
- Further, all the eligible in-service candidates at the time of applying for admission to PG (MD/MS/PG Diploma/MDS) courses for the academic session 2019-20 in the State of Haryana shall be required to have a valid NOC and Experience Certificates issued by the Competent Authority i.e. Health Department, Haryana/ESIC/Concerned Departments, Organizations and autonomous bodies as per their respective Post Graduate course admission policy for inservice candidates.
