LL.M. (ONE YEAR) PROGRAMME FOR THE SESSION – 2019-20

1. The last date for deposit of fee is **July 15, 2019 (5.00 P.M.)** (except 13th - Saturday & 14th - Sunday) for the candidates in the First Merit List as above.
2. The details of the fees as mentioned in the Prospectus at page no. 25 will be accepted through **Demand Draft only (no other mode)** drawn in favour of the **"Indian Law Institute"** payable at New Delhi during 10.00 a.m. to 5.00 p.m. on all working days (**Except Saturday and Sunday**), within the scheduled dates as above.



3. Candidates are to bring all Original Certificates, marksheets starting from Class X onward, SC/ST/OBC/PwD/J&K/EWS certificates, etc., for verification alongwith one set of self attested photocopies thereof and two passport size photographs.
4. **Candidates are to bring Aadhaar Card (which is mandatory as per NAD registration requirement) alongwith one set of self attested photocopy.**
5. **Mandatory Character Certificate from the Institution/ University last attended / Gazetted Officer.**
6. **Migration Certificate from the Institution/ University last attended.**
7. As the course is Full time classroom coaching / research based, candidates serving anywhere have to produce No Objection Certificate and relieving order from the present employer for pursuing the course.
8. Candidates have to make sure that they are eligible for admission to the programme. Any candidate found not eligible anytime during / after admission will be summarily rejected.
9. The candidates appearing / appeared in the qualifying examinations will give an undertaking that they are taking the provisional admission at their own risk and they will submit the final result of the qualifying examination by 15.09.2019, positively.
10. The classes for LL.M. (One year) programme will start w.e.f., 05.08.2019 (Monday).
11. Attendance is a strict measure in Indian Law Institute.
